This deed is given to carry out the mutual desire and agreement of the parties that the property shall become vested in the grantee as her sole and separate property.

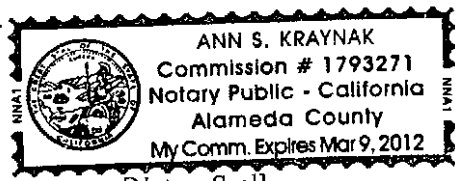
