This Security Instrument will not secure any other debt if Lender fails to give any required notice of the right of rescission.



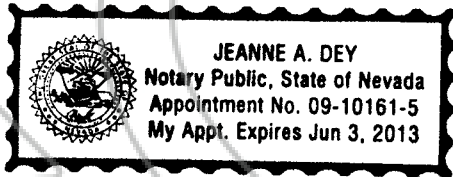
