ASSIGNMENT OF NEGATIVE PLEDGE AGREEMENT

THIS ASSIGNMENT OF NEGATIVE PLEDGE AGREEMENT (this "Assignment") is made and executed as of this 8th day of December, 2011, by Textron Financial Corporation, a Delaware corporation ("Assignor" or "Textron"), in favor of CapitalSource Bank, a California industrial bank ("Assignee").

WITNESSETH:

WHEREAS, capitalized terms used but not defined herein shall have the meanings provided in that certain Purchase Agreement, dated December 8, 2011 (as amended, restated, supplemented, replaced, renewed or otherwise modified from time to time, the "Purchase Agreement"), between Assignee and Assignor; and

WHEREAS, pursuant to the Purchase Agreement, Assignee has agreed to purchase, and Assignor has agreed to sell, upon the terms and conditions set forth in the Purchase Agreement, certain Purchased Assets.

NOW, THEREFORE, in consideration for the payment of the Purchase Price by Assignee, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, conveys, assigns, transfers and sets over (in each case, on an absolute basis) to Assignee, and its successors, representatives and assigns, all of

Assignor's right, title and interest in that certain Negative Pledge Agreement, dated as of May 26, 1999 given by Perennial Vacation Club, Inc., as pledgor, to Textron Financial Corporation, as plegdee, recorded as Instrument # 0470597 in Book 0699 at Page 3950 on June 18, 1999 in the Official Records of the Recorder's Office of Douglas County, Nevada (the "Assigned Interests"). Assignor further transfers, sells, conveys and assigns (in each case, on an absolute basis) to Assignee, and its successors, representatives and assigns, all of its right, title and interest in and to the liens and security interests described in the Assigned Interests, and all of its right, title and interest in and to the indebtedness secured by the Assigned Interests, together with all of its rights, remedies, powers, options, privileges and immunities therein contained (including all guarantees, supporting obligations and collateral relating thereto), subject in each case to the terms and provisions of the Purchase Agreement.

This Assignment is an absolute assignment. This Assignment is without recourse, representation or warranty, express or implied, upon Assignor, except as set forth in the Purchase Agreement.

If any provision of this Assignment is held to be illegal, invalid or unenforceable under present or future laws effective during the term thereof, such provision shall be fully severable, this Assignment shall be construed and enforced as if such illegal, invalid or unenforceable provision had never comprised a part hereof or thereof, and the remaining provisions hereof or thereof shall remain in full force and effect and shall not be affected by the illegal, invalid or unenforceable provision as similar in terms to such illegal, invalid or unenforceable provision as may be possible and be legal, valid and enforceable. This Assignment shall be binding upon Assignor and its successors and assigns, and shall inure to the benefit of Assignee and its successors and assigns.
