
17 **NOTICE IS HEREBY GIVEN** that ANDREW PILLET against defendant STEPHEN H.

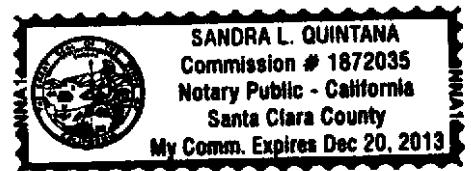
