

- 7. The Obligor shall keep Division of Welfare and Supportive Services informed of any change regarding current employment and of access to health insurance coverage in WRITING (including health insurance policy information) within 10 days of such change.
- 8. Obligor shall be responsible for ALL child support and judgment payments due.

 Payment is to be made directly to the STATE COLLECTION AND DISBURSEMENT

 UNIT (SCaDU). At any time withholding does not occur, Obligor must make

 voluntary payments to the STATE COLLECTION AND DISBURSEMENT UNIT

 (SCaDU).
- 9. Effective July 1, 2004 simple interest will accrue on all adjudicated arrears balances (including payment in lieu of medical insurance) and spousal support balances, for cases with a Nevada controlling order pursuant to NRS 99.040. Interest assessed by a judgment of the court prior to July 1, 2004 will be enforced. Interest on the judgment shall accrue at the rate established by NRS 125B.140(2)(c)(1).
- 10. Pursuant to NRS125B.095, a late fee/penalty of 10% (ten percent) of the unpaid monthly child support amount will be added to the arrears balance of the Obligor if the Obligor becomes delinquent in the amount owed for one month's support.
- 11. The State of Nevada has continuing exclusive jurisdiction for enforcement and modification purposes pursuant to the Full Faith and Credit for Child Support Orders Act.
