CERTIFICATION OF TRUST

Any Trustee has the power and authority to manage and control, buy, sell and transfer the Trust property, in such manner as the Trustee may deem advisable, and shall have, enjoy and exercise all powers and rights over and concerning said property and the proceeds thereof as fully and amply as though said Trustee were the absolute and unqualified owner of same, including the power to grant, bargain, sell and convey, encumber and hypothecate, real and personal property, and the power to invest in corporate obligations of every kind, stocks, preferred or common, and to buy stocks, bonds and similar investments on margin or other leveraged accounts, except to the extent that such management would cause includability of an irrevocable Trust in the estate of a Trustee.
- 4. Following the death of the Trustor, the Trust continues or is distributed in whole or in part for the benefit of other named Beneficiaries according to the terms of the Trust.
- 5. All personal property transferred into Trust remains personal property and all real property transferred into Trust remains real property.

- 6. Unless otherwise indicated to a prospective transferee, the Trustee has full power to transfer assets held in the name of the Trust and subsequent transferees are entitled to rely upon such transfers provided the chain of title is not otherwise deficient.
 - 7. The situs of the Trust is the State of Nevada.
- 8. Declarant states that the Trust is currently funded and in full force and effect, and has not been revoked, modified or otherwise amended in any manner which would cause the representations in this Certification to be incorrect. Declarant Paul C. Roehner is the sole person who has any power to revoke any part of the trust and the Trust will not be revoked as of the date of recording this Certification.
 - 9. The current Tax Identification Number(s) are available by contacting the Trustee.
- 10. Following the death of the Settlor/Trustor, the Trust continues or is distributed in whole or in part for the benefit of other named beneficiaries according to the terms of the Trust.
- 11. The use of this Certificate of Trust is for convenience only and the Trust is solely controlled as to provisions and interpretations, and any conflict between this abstract and the Trust shall be decided in favor of the Trust.
