[Docket Number 133] ("Application") filed with the Court on October 4, 2011, by STEPHEN R. HARRIS, ESQ. of HARRIS & PETRONI, LTD., attorneys for the Debtor JAMES MICHAEL HICKEY, an individual; said Application having been noticed to all creditors and interested parties for hearing on November 1, 2011, at 2:00 p.m.; with STEPHEN R.

3 WILLIAM B. COSSITT, ESQ. appearing on behalf of the Office of the United States Trustee; and
4 the Court having considered all pleadings on file and the oral argument of counsel for the
5 relief requested; and the Court finding that the legal services rendered and costs
6 expended were necessary in order to represent the Debtor in his Chapter 11 case; and
7 no opposition having been filed; and good cause appearing,

8 **IT IS HEREBY ORDERED** that the first and final compensation requested by
9 Debtor's counsel, STEPHEN R. HARRIS, ESQ. of HARRIS-PETRONI, LTD., is ratified
10 and approved for payment as follows: in the total sum of \$89,036.06. This is
11 comprised of total legal fees of \$72,026.25, based on 126.30 hours spent in rendering
12 professional legal services, billed at the rate of \$400.00 per hour for a total of
13 \$50,520.00 for STEPHEN R. HARRIS, ESQ.; \$16,762.50 based on 44.70 hours spent in
14 rendering professional legal services, billed at the rate of \$375.00 per hour for CHRIS D.
15 NICHOLS, ESQ., \$1,087.50 based on 2.90 hours spent in rendering professional legal
16 services, billed at the rate of \$375.00 per hour for GLORIA M. PETRONI, ESQ., and
17 \$3,656.25 based on 16.25 hours spent rendering professional paralegal services, billed
18 at the rate of \$225 per hour. Additionally, the billing includes reimbursement for
19 necessary costs and out-of-pocket expenses that have been expended by Debtor's
20 Counsel in the amount of \$7,009.81 (costs), for a net unpaid first and final fee request
21 of \$79,036.06; plus estimated supplemental legal fees of \$10,000.00 to be incurred
22 from September 1, 2011, through the hearing date of November 1, 2011, for a total
23 unpaid first and final fee request of **\$89,036.06**, for legal services rendered and costs
24 advanced from November 29, 2010, through November 1, 2011; and

25 **IT IS FURTHER ORDERED** that the above-delineated request for payment of first
26 and final legal fees and costs is hereby approved for payment, and is deemed an
27 allowed 11 U.S.C. §503(b) administrative expense to be paid from available
28 unencumbered assets from the bankrupt estate, including funds in the amount of






