THIS MATTER comes before the Court following certain events occurring within the second half of 2011 which pertain to the parties. On July 27, 2011, Terry Lynn Elmer died from injuries sustained during an automobile accident. On August 5, 2011, a child support enforcement hearing which had already been scheduled prior to Mr. Terry's death was convened before a Court Master. That hearing resulted in a recommendation from the Master that child support arrears be reduced to judgment for the following amounts: \$6,076.86 representing principle, interest and penalties regarding child support already due from Obligor Christine Alvarez and \$1,615.99 representing principle, interest and penalties regarding 'medical cash arrears.'

The Court's Amended Order After Hearing On October 13, 2011, filed on November 22, 2011, in Ninth Judicial District Case No. 05-DI-0530, set forth a transition period wherein the parties' youngest minor child was fully placed with Ms. Alvarez as of January 20, 2012. A guardianship has been established for the parties' oldest minor child.

Given these circumstances, any monthly payments resulting from the Master's recommendations would, for the most part, be paid by Ms. Alvarez ultimately to herself. Thus, the Court has refrained from adopting the Master's recommendations. However, according to oral information provided by the Child Support Enforcement Division of the Department of Health and Human Services for the State of Nevada, the State's records reflect that \$1,150 of the arrears previously sought to be reduced to judgment constituted public funds expended on behalf of the parties' minor children, Jacob Lewis Elmer born February 23, 1995, and Mariah Jene Tier Elmer born December 1, 1998, for which the State of Nevada remains obligated to recover from Ms. Alvarez.

THEREFORE, accepting this information, the Court hereby determines that the Obligor Christine Jennifer Elmer, also known as Christine Jennifer Alvarez, is and remains responsible for arrears in the amount of \$1,150 representing public funds expended on behalf of the parties' minor children which are to be repaid to the State of Nevada at a rate of \$50.00 per month beginning April 1, 2012. In the event Ms. Alvarez wishes to contest this amount reduced to arrears, she may request that a hearing be set on the next available hearing calendar of the Court Master by delivering a written request to the Child Support Enforcement Division of the State of Nevada within thirty (30) days from the date of this Order.

Absent such request, monthly payments from Ms. Alvarez are to commence as of April 1, 2012. All payments MUST be made in the form of a money order, cashier's check or

The following information must be included with each payment:

- A. Name (first, middle, last) of person responsible for paying child support.
- B. Social Security Number of person responsible for paying child support.
- C. Child Support case number 3000B listed on each payment.

The Obligor is hereby notified that she is responsible for ensuring that the Division of Welfare and Supportive Services is informed of any change regarding the Obligor's current residential address and place of employment.

Obligor is responsible for ALL payments due toward the arrears judgment. Payment is to be made directly to the STATE COLLECTION AND DISBURSEMENT UNIT (ScaDU). At any time withholding does not occur, Obligor must make voluntary payments to the STATE COLLECTION AND DISBURSEMENT UNIT (ScaDU).

Since this matter now pertains only to the collection of arrears, prospective interest has been waived by the State of Nevada as provided within the Court Master's original recommendation. However, unless a stay of this Order is obtained from the District Court, all enforcement procedures including, but not limited to wage withholding, garnishment, liens and

the attachment of federal income tax returns may be undertaken upon entry of this Order. Any

statutory penalties arising from late payments may also accrue.
