- 8 11, 2012.

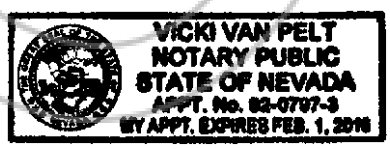
9 9. That as of March 10, 2012, the exact amount due on the costs and




