

IT IS HEREBY ORDERED that the Motions for Attorney's Fees filed by Defendants are GRANTED in part and DENIED in part, and that said defendants shall have a money judgment against Plaintiff GREGORY O. GARMONG, in the following amounts.

IT IS FURTHER ORDERED that Defendants CHARLES GRANT and KATHY GRANT are awarded and judgment entered hereon for their reasonable, actual and necessarily incurred attorney's fees in the amount of Seventy Four Thousand Three Hundred Forty Five Dollars (\$74,345.00) and costs in the amount of Six Thousand Eighty Seven and 02/100 Dollars (\$6,087.02), for a total of Eighty Thousand Four Hundred Thirty Two and 02/100 Dollars (\$80,432.02).

IT IS FURTHER ORDERED that Defendant McFARLAND DOOR MANUFACTURING COMPANY is awarded and judgment entered hereon for its reasonable, actual and necessarily incurred attorney's fees in the amount of Fifty-seven Thousand Eight Hundred Forty Six Dollars (\$57,846.00), and costs in the amount of Four Thousand Six Hundred Ninety-eight and 33/100 Dollars (\$4,698.33), for a total of Sixty-two Thousand Five Hundred Forty-four and 33/100 Dollars (\$62,544.33).

IT IS FURTHER ORDERED that Defendants PETER ROGNEY d.b.a. ROGNEY AND SONS CONSTRUCTION are awarded and judgment entered hereon for their reasonable, actual and necessarily incurred attorney's fees in the amount of Forty-nine Thousand Fifteen Dollars (\$49,015.00), and costs in the amount of Seven Thousand Two Hundred Forty-seven and 80/100 Dollars (\$7,247.80), for a total of Fifty-Six Thousand Two Hundred Sixty-two and 80/100 Dollars (\$56,262.80).
