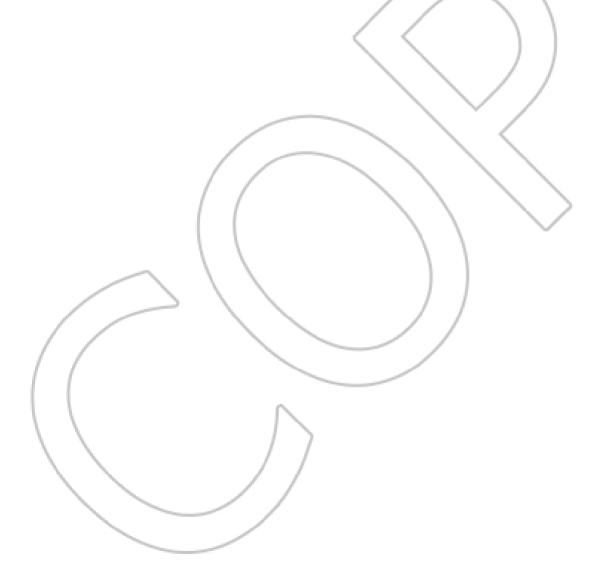

- 3. To Assignor's knowledge, Assignor is transferring the Loan and the Loan Documents free and clear of any and all liens.
