CHILD SUPPORT ARREARS

(*) The Obligor is responsible for **child support** arrears for the period of April 1, 2011 through January 31, 2012.

(*) A judgment is entered against the Obligor for **child support** arrears as follows:

(*) Principal in the amount of \$ 65,010.29

(*) Interest in the amount of \$ 27,253.20

(*) Penalty in the amount of \$ 3479.44

For a total judgment of \$ 95,742.93 to be repaid at \$ 450.00 per month

beginning February 1, 2012.

PAYMENT OF SUPPORT IS TO BE AS PROVIDED HEREIN, AND THE GIVING OF GIFTS, OF MAKING PURCHASES OF FOOD, CLOTHING AND THE LIKE WILL NOT FULFILL THE OBLIGATION.

1 **NOTICE: NO CREDIT WILL BE GIVEN FOR PAYMENTS PAID DIRECTLY TO**
2 **THE OBLIGEE.**

- 3 3. All payments shall be made by immediate income withholding. If you pay your child
4 support through income withholding and your full obligation is not met by the amount
5 withheld by your employer, you are responsible to pay the difference between your court
6 ordered obligation and the amount withheld by your employer directly to the STATE
7 COLLECTION AND DISBURSEMENT UNIT (SCaDU). If you fail to do so you will
8 be subject to the assessment of penalties and interest. You may avoid these additional
9 costs by making your current child support payments each month.
- 10 4. Except as modified herein the terms, conditions and obligations set forth in prior orders
11 shall remain in full force and effect.
- 12 5. The Obligor shall keep Division of Welfare and Supportive Services informed of any
13 change regarding current employment and of access to health insurance coverage in
14 **WRITING** (including health insurance policy information) within 10 days of such.
- 15 6. Obligor shall be responsible for ALL child support and judgment payments due. Payment
16 is to be made directly to the STATE COLLECTION AND DISBURSEMENT UNIT
17 (SCaDU). At any time withholding does not occur, Obligor must make voluntary
18 payments to the STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU).
- 19 7. Effective July 1, 2004 simple interest will accrue on all adjudicated arrears balances
20 (including payment in lieu of medical insurance) and spousal support balances, for cases
21 with a Nevada controlling order pursuant to NRS 99.040. Interest assessed by a
22 judgment of the court prior to July 1, 2004 will be enforced. Interest on the judgment
23 shall accrue at the rate established by NRS 125B.140(2)(c)(1).
- 24 8. Pursuant to NRS 125B.095, a late fee/penalty of 10% (ten percent) of the unpaid monthly
25 child support amount will be added to the arrears balance of the Obligor if the Obligor
26 becomes delinquent in the amount owed for one month's support.
- 27 9. The State of Nevada has continuing exclusive jurisdiction for enforcement and
28 modification purposes pursuant to the Full Faith and Credit for Child Support Orders Act.

1 It is further ordered that: Arrears only case. The Division was
2 ordered to monitor case for possible contempt
3 action if Obligor does not make consistent monthly
4 payments.
