WHEREAS, HENRIETTA M CANNON



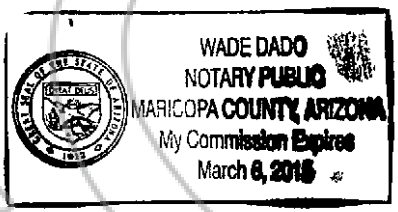
