23 Appraisal.


24 Counsel for Conservator informed the Court of the benefit to Conservatee to receive

26 THOMAS N. ANDREWS concurred.


27 Therefore, IT IS ORDERED that:

28 1. The Conservator is authorized to transfer all assets titled in Conservatee's name, whether

1 real or personal property, whether presently held or received in the future, to SYLVIA  
2 MULVIHILL in repayment of monies advanced for the benefit of the Conservatee. Conservator  
3 is to reserve \$2,000.00 for Conservatee, as allowed by Medi-Cal rules.
