PROPOSEDI-ORDER GRANTING PLAINTIFF'S MOTION FOR SUMMARY JUDGMENT AND ENTRY OF **JUDGMENT**

The Court having examined Plaintiff Douglas County's Motion for Summary Judgment Against P51 Court, LLC; P51 Court, LLC's Motion for Continuance; and the other papers and pleadings on file herein; and the Court having considered the arguments of the parties, and other good cause showing:

The Court finds that, although it granted P51 Court, LLC ("P51 Court") 60 days to conduct discovery and to submit a response to Plaintiff's Motion for Summary Judgment, P51 Court neither conducted any discovery nor filed an opposition to Plaintiff's Motion for Summary Judgment.

The Court further finds that Douglas County provided notice to P51 Court of its failure to comply with numerous terms of that certain lease entered between Douglas County and Defendant P51 Court, as the successor-in-interest to Defendant Skyline Hangars-Minden, LLC, on or about October 3, 2002, and recorded with the Douglas County Recorder's Office as Document 0554943, Book 1002, Pages 06417-0644, together with any amendments thereto (the "Lease").

The Court further finds that Defendant P51 Court has failed to pay property taxes as required by the terms of the Lease and has not contested the assessment of such taxes as permitted pursuant to NRS 361.356. The Court further finds that there is substantial and compelling evidence that P51 Court:

- 1. Has failed to pay the monthly rent and maintenance fees when due to Plaintiff;
- 2. Has failed to complete the tenant improvements required pursuant to the terms of the Lease;
- 3. Has failed to maintain the landscaping and hangar as required by the terms of the Lease;
- 4. Has failed to maintain the required insurance coverage; and
- 5. Has failed to pay all taxes when due.

The Court further finds that Defendant P51 Court, LLC failed to produce any documents at the mandatory NRCP 16.1 Case Conference that might support its affirmative defenses and has failed to submit any discovery requests to Douglas County since the Joint Case Conference report was filed with the Court.

The Court further finds that P51 Court's failure to file an opposition to Plaintiff's Motion for Summary Judgment may be construed by the Court as an admission that Plaintiff's Motion for Summary Judgment is meritorious and consents to the Court's granting the relief requested by the Plaintiff pursuant to DCR 13(3).

THEREFORE.

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that Plaintiff Douglas County's Motion for Summary Judgment is GRANTED.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that P51 Court, LLC consents to the relief requested by Plaintiff Douglas County and is deemed to have admitted that Plaintiff's factual allegations are true.

IT IS FURTHER ORDERED THAT JUDGMENT BE ENTERED against Defendant P51 Court, LLC, and in favor of Plaintiff Douglas County, in the principal amount of \$66,692.98 in delinquent personal property taxes, together with interest accruing thereon at the highest legal rate until paid in full.

IT IS FURTHER ORDERED THAT JUDGMENT BE ENTERED against Defendant P51 Court, LLC, and in favor of Plaintiff Douglas County, in the principal amount of \$58,924.54 in
