- B. An Amendment to the Declaration was recorded as Document No. 0752403 of the Official Records of Douglas County, Nevada, on October 19, 2009 and is fully incorporated to that Declaration incorporated by this reference as if fully set forth herein.
- C. The real property subject to the Declaration and this Amendment consists of parcels of land described in Exhibit "A" attached hereto and incorporated by this reference as if fully set forth herein.
- D. The Members desire to amend the Declaration in order to provide for the authority of the Association to deannex parcels from the Association as set forth below, which amendment shall be effective upon recordation in the Office of the Recorder of Douglas County, Nevada.

If the Parcel to be deannexed from the Association has water rights appurtenant to the Parcel, those water rights appurtenant to such Parcel are to be transferred to another Parcel or Parcels within the Property. Such deannexation shall be accomplished by the recordation of a Notice of Deannexation in the Douglas County, Nevada Recorder's office, which notice shall legally describe the Parcel to be deannexed and provide that it is no longer subject to the benefits and burdens of this Amended and Restated Declaration.
