## MODIFICATION AGREEMENT

THIS AGREEMENT, is made and entered into this 13th, day of November, 2012, by and between Gary W. Richert and Sarah B. Richert, husband and wife as joint tenants (hereinafter called "Makers") and Hempler LePire, a Nevada General Partnership (hereinafter called "Lenders").

WHEREAS, Makers executed that certain Note dated January 13, 2010, in the amount of TWO HUNDRED FIFTY THOUSAND AND 00/100, (\$250,000.00), in favor of Lender, which Note is secured by that certain Deed of Trust dated January 13, 2010 and executed by Makers, to Northern Nevada Title Company, a Nevada corporation, as ORIGINAL Trustee, for the benefit of Lender, as beneficiary, which Deed of Trust was recorded on January 19, 2010, in Book 0110 Official Records, Page 3502, as Document No. 0757371, in the office of the County Recorder of Douglas, Nevada;

WHEREAS, Makers desire to obtain from Lender certain modifications to the interest rate and monthly installments as called for in said Note;

WHEREAS, Lender is willing to grant said modifications to the interest rate and monthly installments provided that Makers agree to certain modifications in the terms and conditions of said Note;

NOW THEREFORE, in consideration of their mutual covenants and promises, the parties hereto agree as follows:

- 1. The unpaid balance of principal now due upon said promissory note is the sum of \$450,000.00 with interest thereon at the rate of 9% per annum.
- 2. The balance due upon said promissory note as aforesaid shall be paid in the following manner and the terms of said promissory note changed and modified as follows to wit:

An additional advance of \$200,000.00 shall be made on November 19, 2012, making the new principal balance \$650,000.00.

Payable in monthly INTEREST-ONLY installments, or more, on the then unpaid balance, commencing on November 19, 2012 and continuing on the 19<sup>th</sup> day of each and every month until April 19, 2014, at which time a balloon payment of unpaid principal together with accrued interest shall become all due and payable.

(Provided that there are no principal reductions or additions made during the term of the note, the interest only payments shall remain at \$4,875.00 per month, beginning on December 19, 2012.)

3. That in all other respects said note and said deed of trust shall remain unaffected, unchanged and unimpaired by reason of the execution of this agreement.
