IN WITNESS WHEREOF, the Grantor has executed this conveyance the day and year first above written.

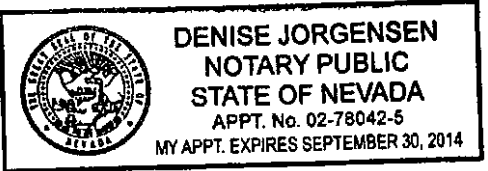
