ADMINISTRATOR'S DEED

COMES NOW, MARILYN DUDLEY, Deceased, by and through CLAUDETTE SPRINGMEYER, Douglas County Public Guardian and Court-appointed Guardian of the Estate of MARILYN DUDLEY, Deceased, as Grantor, and FREDERICK DUDLEY and SUSAN DUDLEY, as individuals and as tenants-in-common, as Grantee, and upon the following recitals, terms and conditions, and for no other consideration, and convey to FREDERICK DUDLEY and SUSAN DUDLEY, as individuals and as tenants-in-common, the Ward's one-third interest in the property hereinbelow described.

WITNESSETH

WHEREAS, on 15 October 2012, the Ninth Judicial District Court entered an Order Terminating Guardianship of Person and Estate and related relief in Case No. 10-PB-0089 in Department II thereof ("Order"); and

WHEREAS, pursuant to the Order, the Court ordered that the Guardian of the estate of MARILYN DUDLEY execute a deed
