IT IS AGREED BETWEEN PARTIES HERETO AS FOLLOWS:

Description of Trust

The undersigned hereto desires to confirm the establishment of a revocable and amendable Living Trust on July 31, 2006, and amendments thereto, for the benefit of the Trustor and containing inter alia the following provisions:

- Edward B. Selcer is designated as the Trustee to serve until his death, resignation or 1. incompetence.
- Upon the removal of the original Trustee, the successor Trustee is designated as 2. Cheryseis Selcer.
