1 as detailed herein, and do hereby authorize the Clerk of the 2 Ninth Judicial District Court of the State of Nevada, in and 3 for the County of Douglas, to enter judgment for said sum against us, singly and collectively, jointly and severally, and in favor of Plaintiff, WILLIAM F. CORNELL, as Trustee of the William F. Cornell Trust, because we have defaulted in 7 making the payments required of us under a 1 Novewmber 2008 super-priority secured promissory note in favor of Plaintiff (the "Note").

This confession of judgment is for money justly due to Plaintiff, WILLIAM F. CORNELL, as Trustee of the William F. Cornell Trust, from us for obligatory payments due under the wherein Defendants acknowledged owing Plaintiff EIGHTY-NINE THOUSAND SIX HUNDRED EIGHTY-EIGHT 27/100 DOLLARS (\$89,688.27); plus interest thereon after 1 November 2008, computed at a rate of 18% per annum to and including 4 June 2009 (i.e., \$5,461), and interest on the foregoing at 20% per annum after 4 June 2009 (i.e., \$7,141), plus \$2,000 toward Plaintiff's attorney's fees paid in aid of collection of the delinquent sum due Plaintiff under the Note.
