


DEED OF FULL RECONVEYANCE



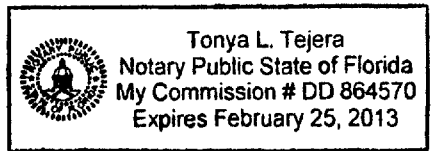

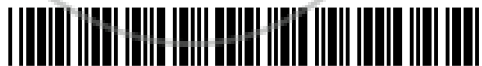
