


DEED OF FULL RECONVEYANCE



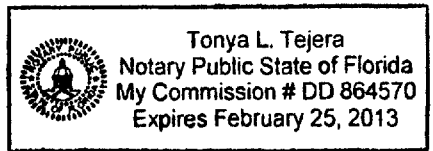
