

5. That there are no counterclaims in favor of the judgment debtor.

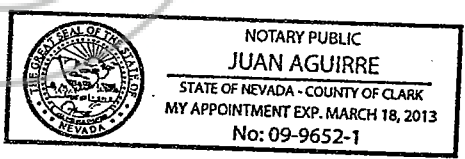
6. That the amount due and owing on the total judgment is \$6,198.60 plus interest at the rate of 0


