WHEREAS, Nevada Revised Statutes 277.180(1) allows any one or more public agency to enter an agreement with any other public agency to perform any governmental service or activity that any of the public agencies entering into the agreement is authorized by law to perform; and

WHEREAS, Douglas County ("County") no longer benefits from small business counseling within close proximity of the resident of the County due to the reduction of the budget of the Nevada Small Business Development Center program; and

WHEREAS, there is a need to provide this service in Douglas County to foster economic development; and

WHEREAS, Douglas County and Carson City have entered an Interlocal Agreement related to the Business Resource Innovation Center recorded as Document 0803395, Book 0612, Page 0803394 (the "BRIC Agreement"), and signed by the Douglas County Manager on May 24, 2012; and

WHEREAS, Douglas County and Carson City mutually desire to extend the BRIC Agreement for another year, from June 1, 2013, through May 30, 2014, pursuant to Paragraph 1 of the BRIC Agreement.

NOW, THEREFORE, in consideration of the agreements herein made, the County and Contractor parties mutually agree as follows:

- 1. EXTENSION OF CONTRACT THROUGH MAY 30, 2014.** Pursuant to Paragraph 1 of the BRIC Agreement, the parties mutually agree to extend the BRIC Agreement for one (1) additional year, from June 1, 2013, through May 30, 2014, inclusive. The Parties agree that the BRIC Agreement may be further extended for additional one-year periods after May 30, 2014, as provided in Paragraph 1 of the BRIC Agreement.

IN WITNESS WHEREOF, the parties have approved and caused this Extension of Interlocal Agreement for the Business Resource Innovation Center to be signed and intend to be legally bound thereby.


