
DEED OF FULL RECONVEYANCE



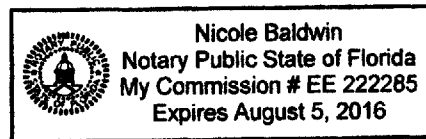
