## AGEEMENT REGARDING WATER RIGHTS

THIS AGREEMENT regarding water rights is entered into this \_\_\_\_\_ day of May, 2013, by and between the Bently Family Limited Partnership (BFLP) and the Edmondson 2001 Trust (Trust), pertaining to water rights associated with property owned by each, as follows:

## **WITNESSETH**

- A. BFLP is the owner of property in Douglas County, Nevada, on Autumn Hills Road identified as Douglas County Assessor's Parcel No. 1219-09-001-018.
- B. BFLP is also the owner of the water rights appurtenant to said property which are represented by Certificate No. 5961 (Application 18720) for 22.84 acre feet of water rights ("Water Rights").
- C. Trust is the owner of adjacent property in Douglas County, Nevada, identified as Douglas County Assessor's Parcel No. 1219-09-001-019.
- D. BFLP and Trust have agreed to a boundary line adjustment whereby a portion of the BFLP property will be purchased by and transferred to the Trust property.
- E. The purpose of this Agreement is to clarify the respective rights and obligations of the parties, as well as the ownership, with reference to the subject Water Rights.

NOW THEREFORE, FOR VALUABLE CONSIDERATION, the receipt of which is hereby acknowledged, the parties agree as follows:

- 1. The Trust acknowledges ownership of the water rights by BFLP appurtenant to the property to be acquired by the Trust and waives any and all claim thereto.
- 2. BFLP acknowledges the existence of water features on the Trust property and on the BFLP property to be acquired by the Trust. BFLP acknowledges the right of Trust to manage said waters in a manner determined by the Trust, subject only to the restrictions that the Trust not interfere with the flow of such waters onto BFLP property, and that the Trust not use any such waters for any consumptive purpose.
- 3. Trust acknowledges the right of BFLP in such Water Rights, and BFLP's ownership thereof, and BFLP's right for access onto Trust's property to manage said water rights as may from time to time be necessary or appropriate to maintain the spring, ditch and Water Rights. Such access shall be based upon a twenty-four (24) hour notice of intent to access by BFLP, which right and such access not be unreasonably refused. Such access shall be by foot or small vehicle, as necessary. BFLP shall endeavor to restore any disturbance caused in connection with its entity and work.
- 4. This Agreement shall inure to the benefit of and shall burden the heirs, successors, assigns and grantees of the referenced property owned by the Trust and by BFLP. The referenced water rights shall be hereafter managed and used in accordance with this Agreement.
