6 5. The Judgment has been partially satisfied in the amount of \$.00.



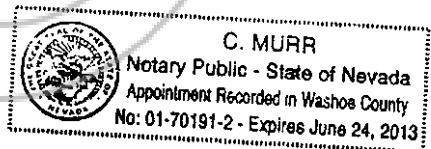


