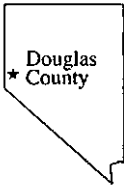

CERTIFICATION

I, **TED THRAN**, Clerk-Treasurer of the County of Douglas, State of Nevada, do hereby certify that the following taxpayers were assessed for the property in Douglas County, Nevada, for the year 2012-2013 and that the taxes, not having been paid, became delinquent on the March 14, 2013.
