WHEREFORE, by virtue of the law and by reason of the premises aforesaid, it is Ordered, Adjudged and Decreed, that the Plaintiff have and recover from the Defendant VENCENT H VERNAZA, the sum of \$28,941.76, less satisfaction of \$16,600.00, plus cost of repossession of \$342.50, for a principle sum of \$12,684.26, together with accrued interest in the amount of \$9,458.17, Plaintiff's costs and disbursements incurred in this action in the amount of \$392.00 and attorney's fees of \$ 750⁰⁰. Said stated accrued interest was calculated on the principal balance at the rate of 11.490% per annum from the date the debt was incurred which was November 16, 2009. Interest shall continue to accrue at the statutory rate from the date of this judgment until this debt is paid in full.

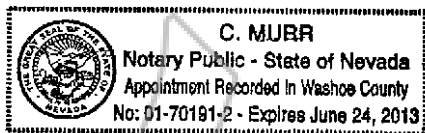


