NOW, THEREFORE, in consideration of the agreements herein made, the County and Contractor parties mutually agree as follows:

1. EXTENSION OF CONTRACT THROUGH JUNE 30, 2014. Pursuant to Paragraph 1 of the SAFE Contract, the parties mutually agree to extend the SAFE Contract for one additional year, from July 1, 2013, through June 30, 2014, inclusive.
