25 **IT IS HEREBY ORDERED AND ADJUDGED that an attorney's lien in**

 5 and costs incurred by him in pursuit of the execution of this
 6 judgment.

8 IT IS FURTHER ORDERED AND ADJUDGED that the attorney's lien
 9 and personal judgment against Tisha may be placed of record upon
 10 Tisha's real or personal property and the Law Office Kathleen B.
 11 Kelly, shall proceed with all available execution remedies.

13 IT IS FINALLY ORDERED that movant may proceed with any and
 14 all additional methods of execution available.




