GENERAL POWER OF ATTORNEY

PREAMBLE: This is a MILITARY POWER OF ATTORNEY prepared pursuant to Title 10 United States Code, Section 1044b, and executed by a person authorized to receive legal assistance from the military services. - To lease, sell, use, establish title to, register, insure, transfer, mortgage, maintain, manage, pledge, exchange or otherwise dispose of or encumber any and all of my property, real, personal, or mixed, including motor vehicles of any kind, and to execute and deliver good and sufficient deeds or other instruments for the lease, conveyance, mortgage, maintenance, or transfer of the same.
- To buy, receive, lease, accept or otherwise acquire in my name and for my account, property, real, personal or mixed upon such terms, considerations and conditions as my attorney-in-fact shall deem appropriate.
- To transact all business of mine on my behalf including entering into contracts and the making of such investments as my attorney-in-fact shall deem sound.
- To institute and prosecute, or to appear and defend, or to settle, any claims or litigation involving me or my interests. This shall include, but not be limited to, the authority to present a claim against the United States for damage to or loss of personal property.
 - To prepare, execute, sign, and file all tax returns and to receive and negotiate all tax refund checks.
- To execute all documents needed for travel of my family members and transportation or storage of my property, as authorized by law and military regulations; to sign for and clear government or other quarters in the best interests of my family members and in accordance with law and military regulations.
- To demand, act to recover, and receive, all sums of money which are now or will become owing or belonging to me, and to institute accounts on my behalf and to deposit, draw upon, or expend such funds of mine as are necessary in furtherance of the powers granted herein. This shall include, but not be limited to, the authority to receive, endorse, cash, or deposit negotiable instruments made payable to me and drawn upon the Treasurer, or other fiscal officer or depository, of the United States.
- Generally to do, execute, and perform any other act, deed, matter, or thing, that in the opinion of my attorney-in-fact cught to be done, executed, or performed, in conjunction with this power of attorney.
- -NOTWITHSTANDING any language to the contrary in this instrument, my attorney-in-fact is specifically NOT granted the following powers:
 - To cancel or change the beneficiary of any policy of life insurance owned by me. a.
 - To exercise any rights or powers with respect to any person, matter, transaction or property in my name or b. in my custody as a trustee, custodian, personal representative or other fiduciary capacity for someone else.

All business transacted herefunder for me or for my account shall be transacted in my name, and all endorsements and instruments executed by my attorney for the purpose of carrying out the foregoing powers shall contain my name, followed by that of my attorney and the designation "attorney-in-fact."
