

Amendment No. 2 to Grantee Agreement No. P168-12-802

This Amendment is made and entered into this **2/31** day of **December**, 2012, between the State of Nevada, Department of Transportation, hereinafter referred to as the DEPARTMENT, and the Douglas Area Rural Transit (DART), a governmental agency, hereinafter called "GRANTEE".

WITNESSETH:

WHEREAS, on May 15, 2012 the Parties entered into Agreement No. P168-12-802 to provide for the availability of federal funds for capital acquisitions, program administration, and operating assistance in small urban and rural areas of the State by way of Federal Transit Administration (FTA) Formula Grant Program 5311, American Recovery and Reinvestment Act of 2009, to be administered by the DEPARTMENT; and

WHEREAS, this Amendment No. 2 extends the termination date for additional time to reimburse the GRANTEE as provided for under Agreement No. P168-12-802 and increases the agreement amount; and

WHEREAS, the parties hereto desire to make certain amendments to Agreement No. P168-12-802.

NOW, THEREFORE, the parties agree as follows:

- A. The termination date referenced in Article III, Paragraph 1, shall be changed from January 31, 2013 to March 31, 2013.
- B. The agreement amount referenced in Article I, Paragraph 2 and Article 3, Paragraphs 5 and 6, is Increased from Five Hundred Seventy-Five Thousand and No/100 Dollars (\$575,000.00) to Six Hundred Thousand and No/00 Dollars (\$600,000.00) in FTA ARRA funds.
- C. All of the other provisions of Agreement No. P168-12-802 dated May 15, 2012 and Amendment No. 1, dated August 23, 2012, shall remain in full force and effect as set forth herein.
