
DEED OF FULL RECONVEYANCE

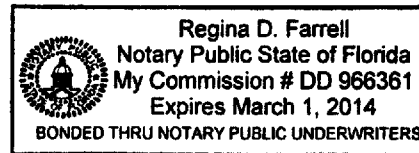
