DEED OF FULL RECONVEYANCE



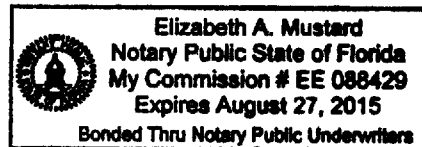
