DEFINITIONS

- (A) **"Security Instrument"** means this document, which is dated October 14, 2013, together with all Riders to this document.


MASTER FORM DEED OF TRUST

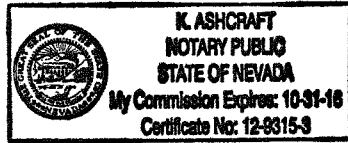


