Paula S. Meier and Ken Meier, successor Co-Trustees, being first duly sworn, depose and say:

That Marvin A. Linder and Rosalind Linder executed a Trust Agreement on July 20, 2000. Marvin A. Linder and Rosalind Linder were the Trustors and Co-Trustees of said Trust, known as the "Linder 2000 Revocable Trust Agreement dated July 20, 2000.
