18 Pursuant to the Stipulation for Judgment on file herein and good cause appearing
19 therefor;

21 IT IS HEREBY ORDERED that judgment is entered on behalf of the Plaintiff against
22 MATT CRITTENDEN, in the principal amount of \$981.89, plus prejudgment interest at the
23 rate of 7.450% per annum from February 22, 2013 until entry of judgment, plus attorney's
24 fees of \$400.00, plus costs of suit in the amount of \$271.30, with post-judgment interest
25 accruing on the entire judgment at the legal rate from the date of entry of judgment.

1 IT IS FURTHER ORDERED that Plaintiff shall refrain from execution on the
2 judgment provided MATT CRITTENDEN voluntarily pays Plaintiff the sum of \$1,298.68,
3 plus interest and costs, and without attorney's fees, in accordance with the following schedule:

4 Commencing October 25, 2013, \$150.00 per month due on or before the 25th day of
5 each month and continuing thereafter until paid in full.

7 Each payment shall be applied first to any outstanding interest with the remainder applied to
8 the unpaid judgment which contains costs, fees, principal and prejudgment interest.

9 In the event of default by MATT CRITTENDEN under the stipulated payment plan,
10 Plaintiff shall be entitled to execute on the full judgment, which includes attorney's fees in the
11 amount of \$400.00, with post-judgment interest accruing on the entire judgment at the legal
12 rate from the date of entry of judgment.
