## AGREEMENT FOR SEWER LINE CONSTRUCTION

2013 DEC 20 AM 9: 29

THIS AGREEMENT FOR SEWER LINE CONSTRUCTION ("Agreement") ISCLERY entered into between Douglas County ("County"), a political subdivision of the State of Nevada, and Clear Creek Residential, LLC (the "Developer"). County and Developer are at times collectively referred to herein as the "Parties" or individually as the "Party."

## **PREAMBLE**

WHEREAS, on November 6, 2003, the Board of County Commissioners adopted Ordinance 2003-1005 for Clear Creek Residential, LLC, including the Planned Development and Specific Plan, PD 03-004 ("PD 03-004"), subject to specific conditions (the "Development");

WHEREAS, Condition 4, "Sewer System," of PD 03-004 requires the Developer to design and construct a public sewer system serving the Development and to connect the Developer's sewer system to the County's sewer system at Jacks Valley Road and U.S. Hwy 395 with Phase I of the Development;

WHEREAS, the Developer has requested that the Douglas County Community Development Department modify Conditions 2a, 2b, and 5 of PD-03-004 related to the water and sewer system improvements and phasing for the Development;

WHEREAS, the public sewer system serving the Development will be dedicated to the County for maintenance and operations;

WHEREAS, the County and Carson City desire to enter into an Interlocal Agreement for Carson City to provide sewer service to the Development;

WHEREAS, the Carson City sewer lines and associated public sewer facilities generally located east of Highway 395 in Old Clear Creek Road requires expansion and upsizing to accept the projected increased sewer and wastewater flows from the Development;

WHEREAS, Article II, Paragraph 4, of the Interlocal Agreement between the County and Carson City requires the County to pay to Carson City its prorated share of construction costs equal to 40% of the final project costs to increase the sewer capacity of the sewer line and related sewer facilities; and

WHEREAS, the Development has agreed to pay to Carson City any monies the County may owe to increase the capacity of the sewer line.

**NOW, THEREFORE**, based on good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and the mutual promises and conditions contained herein, the Parties agree as follows:

- 1. Douglas County agrees to enter into an Interlocal Agreement with Carson City to provide sewer services for the Development.
- 2. Developer agrees to deposit with Carson City forty percent (40%) of the estimated cost to increase the capacity of the sewer line and related sewer facilities within thirty (30) days of the award of bids and the final adjusted cost within thirty (30) days once a Notice of Completion is issued for the sewer improvement project. Developer is solely responsible for paying all applicable sewer connection charges and fees directly to Carson City related to the Development. For reference, maps graphically displaying the potential improvements to be constructed by Carson City are attached as Exhibit "A."
- 3. All notices, requests, or approvals required or permitted to be given under this Agreement must be in writing and be sent by hand delivery, overnight carrier, or by U.S. Mail postage prepaid to the following:

- 4. This Agreement contains the entire agreement between the Parties relating to the subject matter. No change, amendment, alteration or modification of this Agreement will be effective unless documented in writing and executed by both Parties.
- 5. The Agreement will be construed and interpreted according to the laws of the State of Nevada. There will be no presumption for or against the drafter in interpreting or enforcing the Agreement. In the event a dispute arises between the Parties, the Parties promise and agree to first meet and confer to resolve any dispute. If such meeting does not resolve the dispute, then the Parties agree to mediate any dispute arising from or relating to the Agreement before an independent mediator mutually agreed to by the Parties. The fee, rate or charge of the mediator will be shared equally by the Parties, who will otherwise be responsible for their own attorney's fees and costs. If mediation is unsuccessful, litigation may only proceed in the Ninth Judicial Court of the State of Nevada in and for the County of Douglas and attorney's fees and costs will be awarded to the prevailing Party at the discretion of the court.

- 6. This Agreement shall bind and inure to the benefit of the respective successors and any assigns to the Parties.
- 7. The Parties represent and warrant that they have the authority to enter into this Agreement.
- 8. Nothing contained in this Agreement is intended to convey any rights or to create a contractual relationship with any third party or to otherwise allow a third party to assert a cause of action against any of the Parties.




