AN ORDER OF ABANDONMENT VACATING 11,129 SQUARE FEET, MORE OR LESS, OF THE BOUGAINVILLEA DRIVE RIGHT-OF-WAY, THE AREA IS LOCATED NEAR THE INTERSECTION OF HEYBOURNE ROAD AND BOUGAINVILLEA DRIVE, WITHIN THE SFR-12,000/PD (SINGLE FAMILY RESIDENTIAL, 12,000 SQUARE FOOT MINIMUM NET PARCEL SIZE) WITH A PLANNED DEVELOPMENT OVERLAY AND SFR-12,000 (SINGLE FAMILY RESIDENTIAL, 12,000 SQUARE FOOT MINIMUM PARCEL SIZE) ZONING DISTRICTS IN THE MINDEN/GARDNERVILLE PLANNING AREA (BETWEEN APNS: 1320-29-212-060 & -061) IN DOUGLAS COUNTY, NEVADA.

WHEREAS, Douglas County, a political subdivision of the State of Nevada, presently holds a public right-of-way interest for a strip of land for roadway purposes located within a portion of Section 29, Township 13 North, Range 20 East, Mount Diablo Meridian, more particularly described in the attached legal description and depicted in the attached exhibit provided as Exhibit A; and

WHEREAS, Douglas County, pursuant to the provisions of NRS 278.480, may vacate or abandon by formal order any portion of a public roadway; and

WHEREAS, on April 4, 2013, the Douglas County Board of Commissioners held a public hearing to take testimony for said abandonment and found that the subject right-of-way to be in excess of the needs of Douglas County, and that the public will not be materially injured by the abandonment; and

NOW THEREFORE, be it ordered by the Board of Douglas County Commissioners, that the aforesaid right-of-way and incidents thereto, as described in the attached legal description and depicted in the attached exhibit provided as Exhibit A, is hereby abandoned subject to the following conditions and stipulations:

- 1. The applicants must record a Public Utility Easement for the purpose of operation, maintenance, and reasonable repair to the satisfaction of the applicable utility providers.
- 2. The applicant must record a Record of Survey for the abandonment.
- 3. The applicant must ensure that the abandonment of the right-of-way is consistent with Sections 278.240 and 278.480 of the Nevada Revised Statute.

- 4. The applicant shall obtain the dedication of 3,748 square feet of public right-of-way for the new Bougainvillea Drive alignment to Douglas County as shown on the Exhibit entitled "Public Road Right-of-Way for the Realignment of Bougainvillea Drive Douglas County, Nevada".
- 5. The applicant must record new deeds that accurately describe the boundaries for the new parcels created by the Bougainvillea Drive Road Abandonment and the remaining portion of parcel APN 1320-29-212-061.
- 6. The applicant must submit a digital copy of the abandonment and dedication exhibit to the Geographic Information Systems (GIS) Division.
- 7. The applicant must meet all of the conditions of approval and the Order of Abandonment must be recorded within two years or this approval will expire. Extensions of time may be granted in accordance with Douglas County Code, Section 20.30.020.
