NOTICE OF DEFAULT AND ELECTION TO SELL

The Notice of Delinquent Assessment and Claim of Lien ("NODA") of Pine View Estates Homeowners Association recorded October 2, 2013 as Document No. 0831587 of Official Records of Douglas County, State of Nevada, securing the obligation of the assessments which was a deficiency in the amount of \$1,480.00, as of the date of the NODA, plus the accruing assessments since that time, late charges, advances, attorney's fees and costs of the agent of the Association.

The total due as of this date is \$2,767.25. The deficiency continues to accrue assessments, late charges, advances, attorney's fees and costs.

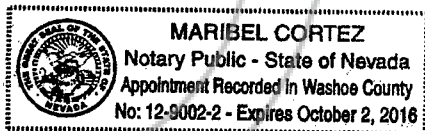
