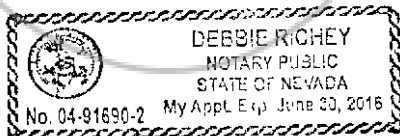

- 17 2. (X) That said child's birth certificate be amended by entering the name of AUSTIN
- 18 MYLES WALRATH as the father of said child and that the Court order the state
- 19 registrar of vital statistics to prepare an amended certificate of birth consistent with this
- 20 order.

- 21 3. (X) Ongoing support is ordered in the amount of \$176.00 per month beginning
- 22 December 1, 2013. The obligation for Child Support continues until the child turns 18
- 23 years of age, or until the child turns 19 years of age if the child is enrolled in High
- 24 School. However, this obligation to support a child is affected by a child's ability to live
- 25 on their own (NRS129.080 to 129.140 – legal emancipation) or when applicable,
- 26 continued financial support beyond the age of majority per NRS125B.110.

- 27 4. (X) The Obligor is responsible for **child support** arrears for the period of
- 28 September 1, 2013 through November 30, 2013 .

- 25 D. Name of custodian (first and last name of person receiving child support).

26 **PAYMENT OF SUPPORT IS TO BE AS PROVIDED HEREIN, AND THE GIVING**
27 **OF GIFTS, OF MAKING PURCHASES OF FOOD, CLOTHING AND THE LIKE**
28 **WILL NOT FULFILL THE OBLIGATION.**

NOTICE: NO CREDIT WILL BE GIVEN FOR PAYMENTS PAID DIRECTLY TO THE OBLIGEE.

6. All payments shall be made by immediate income withholding. If you pay your child support through income withholding and your full obligation is not met by the amount withheld by your employer, you are responsible to pay the difference between your court ordered obligation and the amount withheld by your employer directly to the STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU). If you fail to do so you will be subject to the assessment of penalties and interest. You may avoid these additional costs by making your current child support payments each month.

7. (X) The Obligee shall provide health insurance coverage for the child when available through employment or group policy under a plan that is reasonable in cost as defined in NRS 125B.085 and Obligor shall pay \$ 67.00 per month for health insurance premium (medical cash) effective December 1, 2013.

Medical costs incurred for the above-referenced period have not yet been determined. The State's right to recover said costs is not waived by way of this order.

8. () Obligor (X) Obligee shall provide proof of insurance coverage including an insurance identification card and insurance plan provider list to the Division of Welfare and Supportive Services Office, within fifteen (15) days of today's date.

9. (X) Pursuant to NRS 125B.080(7), expenses for health care which are not reimbursed through insurance, including expenses for medical, surgical, dental, orthodontic and optical expenses, must be shared equally by both parents.

10. (X) The Obligor shall pay and judgment is entered in favor of the Division of Welfare Supportive Services for the reimbursement of genetic test fees totaling \$114.00, to be paid by payments of \$ 10.00 per month beginning December 1, 2013.

11. Except as modified herein the terms, conditions and obligations set forth in prior orders shall remain in full force and effect.

12. The Obligor shall keep Division of Welfare and Supportive Services informed of any change regarding current employment and of access to health insurance coverage in **WRITING** (including health insurance policy information) within 10 days of such.

13. Obligor shall be responsible for ALL child support and judgment payments due. Payment is to be made directly to the STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU). At any time withholding does not occur, Obligor must make voluntary payments to the STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU).

14. Effective July 1, 2004 simple interest will accrue on all adjudicated arrears balances (including payment in lieu of medical insurance) and spousal support balances, for cases with a Nevada controlling order pursuant to NRS 99.040. Interest assessed by a judgment of the court prior to July 1, 2004 will be enforced. Interest on the judgment shall accrue at the rate established by NRS 125B.140(2)(c)(1).

15. Pursuant to NRS 125B.095, a late fee/penalty of 10% (ten percent) of the unpaid monthly child support amount will be added to the arrears balance of the Obligor if the Obligor becomes delinquent in the amount owed for one month's support.

16. The State of Nevada has continuing exclusive jurisdiction for enforcement and modification purposes pursuant to the Full Faith and Credit for Child Support Orders Act.

It is further ordered that: Paternity for child Gabriel Myles Peterson confirmed pursuant to positive genetic testing. Obligor ordered to pay for one-half cost of child's health insurance premium although it exceeds 5% of his gross monthly income as court finds him to be underemployed.
