- 9. (X) Pursuant to NRS 125B.080(7), expenses for health care which are not reimbursed through insurance, including expenses for medical, surgical, dental, orthodontic and optical expenses, must be shared equally by both parents.
- 10. (X) The Obligor shall pay and judgment is entered in favor of the Division of Welfare Supportive Services for the reimbursement of genetic test fees totaling \$114.00, to be paid by payments of \$10.00 per month beginning December 1, 2013.
- 11. Except as modified herein the terms, conditions and obligations set forth in prior orders shall remain in full force and effect.

The Obligor shall keep Division of Welfare and Supportive Services informed of any 12. change regarding current employment and of access to health insurance coverage in WRITING (including health insurance policy information) within 10 days of such. Obligor shall be responsible for ALL child support and judgment payments due. 13. Payment is to be made directly to the STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU). At any time withholding does not occur, Obligor must make voluntary payments to the STATE COLLECTION AND DISBURSEMENT UNIT (SCaDU). Effective July 1, 2004 simple interest will accrue on all adjudicated arrears balances 14. (including payment in lieu of medical insurance) and spousal support balances, for cases with a Nevada controlling order pursuant to NRS 99.040. Interest assessed by a judgment of the court prior to July 1, 2004 will be enforced. Interest on the judgment shall accrue at the rate established by NRS 125B.140(2)(c)(1).
