CERTIFICATE OF TRUST THE WILLIAMS FAMILY CREDIT TRUST

The undersigned hereby certifies that on December 31, 2013, she created an irrevocable Trust as the result of a sub-trust provision in The Williams Revocable Trust, under trust dated January 27, 2010. This Sub-Trust is known as: THE WILLIAMS FAMILY CREDIT TRUST dated December 13, 2013, Anna Laura Williams, Trustee and Trustor for the benefit of the Thomas VanBuren Williams and Anna Laura Williams' family.

IT IS AGREED BETWEEN PARTIES HERETO AS FOLLOWS:

Description of Trust The undersigned hereto desires to confirm the establishment of an irrevocable and non-amendable Trust on December 31, 2013, for the benefit of the Surviving Trustor of The Williams Revocable Trust and containing inter alia the following provisions:

- Anna Laura Williams is designated as the Trustee to serve until her death, resignation or 1. incompetence.
- 2. Upon the removal of the original Trustee, the successor Co-Trustees are designated as Gary Lynn Williams and Stephen Lewis Hall. Should one of the just named persons predecease the surviving Trustor or fail or refuse to serve, then the remaining person shall serve as Trustee.
- Any Trustee has the power and authority to manage and control, buy, sell and transfer the Trust property, in such manner as the Trustee may deem advisable, and shall have, enjoy and exercise all powers and rights over and concerning said property and the proceeds thereof as fully and amply as though said Trustee were the absolute and unqualified owner of same, including the power to grant, bargain, sell and convey, encumber and hypothecate, real and personal property, and the power to invest in corporate obligations of every kind, stocks, preferred or common, and to buy stocks, bonds and similar investments on margin or other leveraged accounts, except to



the extent that such management would cause includability of an irrevocable Trust in the estate of a Trustee.

- 4. During the life of the surviving Trustor and Trustee, Anna Laura Williams, the Trustee may distribute \$5,000 or five percent of the value of the principal of the Williams Family Credit Trust to the surviving spouse, Anna Laura Williams, annually. Following the death of the Trustor, the Trust continues or is distributed in whole or in part for the benefit of other named Beneficiaries according to the terms of the Trust.
- 5. Notwithstanding anything herein contained to the contrary, the surviving Trustor shall have no right to participate in any decisions affecting the Family Credit Trust which might result in the inclusion of the principal thereof in surviving Trustor's estate for federal estate tax purposes.
- 6. While the Trustor is living and competent, the Trustee may add money to or withdraw money from any bank or savings and loan or checking account owned by the Trust without the approval of the Trustor.
- 7. All personal property transferred into Trust remains personal property and all real property transferred into Trust remains real property.
- 8. Unless otherwise indicated to a prospective transferee, the Trustee has full power to transfer assets held in the name of the Trust and subsequent transferees are entitled to rely upon such transfers provided the chain of title is not otherwise deficient.
- 9. The situs of the Trust is the State of Nevada.
- 10. This Trust contains a spendthrift provision to the extent available under the laws of the State of Nevada.
- 11. The use of this Certificate of Trust is for convenience only and the Trust is solely controlled as to provisions and interpretations, and any conflict between this certificate and the Trust shall be decided in favor of the Trust.
