NOTICE TERMINATION OF TEMPORARY GRANT OF RIGHT-OF-ENTRY AND TEMPORARY CONSTRUCTION EASEMENT(S)

This Notice of Termination of Temporary Grant of Right-of-Entry and Temporary Construction Easement(s) is being recorded to acknowledge, verify and confirm the termination of the Temporary Grant of Right-of-Entry and Temporary Construction Easement(s) recorded as Document# 0801629, Book 0412, Pages 8124-8133 in the Official Record of Douglas County ("Temporary Easements") by and between Ranch No. 1 Limited Partnership, ("Grantor"), and Douglas County Redevelopment Agency, a political subdivision of the State of Nevada, created pursuant to Nevada Revised Statutes (NRS) Chapter 279 and Ordinance 98-846, as amended, ("Grantee").

Grantee hereby acknowledges, verifies, and confirms the Temporary Easements automatically terminated per the explicit terms of paragraph three of the recorded Temporary Easements document. The purpose of the Temporary Easements has been fulfilled as the improvements, facilities and appurtenances associated with the Genoa Vista Trail have been constructed and it has been more than 12 months from the date the construction bid for the trail improvements was awarded. The Grantee's and any successor or assignee's rights are determined by the Grant of Permanent Easements, recorded as Document# 0801652, Book 0412, beginning at Page 8256. The Temporary Easements are no longer effective and have terminated.
