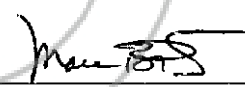
WHEREAS, the undersigned wishes to rescind said Notice of Default and Election to Sell.

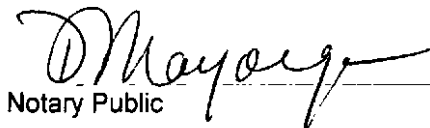

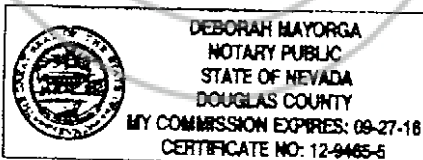
