## Agreement for Administrative Consolidation between Ted Thran – Douglas County Clerk/Treasurer, and

## The Douglas County Judiciary

WHEREAS, the Ninth Judicial District Court and the East Fork and Tahoe Justice Courts, hereafter collectively referred to as "The Courts," desire to integrate and/or merge responsibilities and functions associated with court management, central services and operational infrastructures;

WHEREAS, Ted Thran, as the elected Douglas County Clerk/Treasurer, is the exofficio Clerk of the Courts for the Ninth Judicial District Court, the East Fork Justice Court, and the Tahoe Justice Court;

WHEREAS, the Nevada Supreme Court has filed its decision in State, ex. rel. Harvey v. The Second Judicial Dist. Court, holding that the designation of the county clerk as ex officio clerk of the court reflects nothing more than an effort by the drafter's of Nevada's constitution to increase efficiency by allowing the county clerk to perform court-related duties;

WHEREAS, Ted Thran, Douglas County Clerk/Treasurer, agrees that the ministerial duties of ex-officio clerk of the court should be integrated into the responsibilities and functions of court management;

WHEREAS, The Courts agree that the ministerial duties of the County Clerk as exofficio clerk of the court should be integrated into the responsibilities and functions of court management;

WHEREAS, the Nevada Constitution was designed to promote and preserve the fundamental concept of three independent branches of government, specifically providing for an independent judiciary exercising direct control over the personnel performing vital and essential court functions;

WHEREAS, Ted Thran, Douglas County Clerk/Treasurer, agrees that any and all financial duties, including but not limited to collection of fines and any fees imposed pursuant to NRS 19.013 performed by the County Clerk/Treasurer should be integrated into the responsibilities and functions of court management;

THEREFORE, it is hereby agreed by and between, Ted Thran, Douglas County Clerk/Treasurer and The Courts that the ministerial and supervisory duties of the
