**CERTIFICATE OF LOCATION**  
**LODE MINING CLAIM - NEVADA**

The Lode Mining Claim is situated in Douglas and Lyon Counties, State of Nevada, Mt Diablo Meridian;

The boundaries of the claim are marked by four substantial monuments, one at each corner of the claim. Said monuments consist of 2x2 nominal posts at least 4 feet in length. Each monument is marked with a scribed metal tag, which states the claim name and number, and the location of the monument with respect to the claim. Further described as follows:

- Beginning at the northeast corner of the claim, post No. 1
- Thence 600 feet in a southerly direction to post No. 2,
- Thence 1500 feet in a westerly direction to post No. 3,
- Thence 600 feet in a northerly direction to post No. 4,
- Thence 1500 feet in a easterly direction, returning to post No. 1.

The claim is approximately 1500 feet long and 600 feet wide, such that 1490 feet are claimed in a easterly direction and 10 feet in a westerly direction from the point of discovery (monument of location), at which the Notice of Location was posted, together with 300 on each side of the monument of location and center line of the Claim. The general course of the lode or vein is from the easterly to westerly direction.

To tie this claim to the Public Survey, begin at the NE corner, Section 17, Township 13N, Range 24E, Mt Diablo Meridian; bear West, 1027 feet, and South, 2660 feet to the Location Monument of this Claim. The end lines are parallel to each other. The claim is located in the following quarter sections:
