DEFINITIONS

- (A) **"Security Instrument"** means this document, which is dated June 25, 2014, together with all Riders to this document.



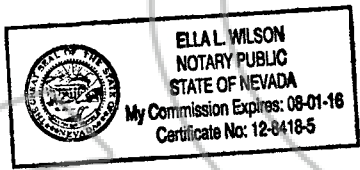


